This Privacy Policy outlines the procedures for gathering, using, disclosing, and handling your personal information, and, your choices and rights concerning your personal information.

Personal Information Collected from You

We obtain information from you by the inputs you provide on the landing page. The information that we ask you to provide may include your first and last name, age, gender, contact details (mailing address/telephone number/email address), and information relating to your medical conditions and history. The data is double encrypted. Only administrator will have access to the data. Data is stored on a secured Indegene AWS cloud and all participant information is encrypted AES256

Only the required personal information and medical information is collected and processed by coralcoughtrial.com to fulfil the intended uses.

Information we collect automatically when you access the website or services:

When you visit our website or use our services, including when you browse the website or take specific activities on the website or services, we may collect information about you. For instance, we keep track of your name, contact details, location, and email address when you log into website or our services to create audit trails only after obtaining your consent. When you visit the website for first time, cookie consent is taken on cookie banner and through preference centre.

Consolidation of Information Collected from You

Data collected from you will only be used for this trial only. We may merge your Personal Data with computer information acquired when you register with us more than once and store it as a single entity. This makes it easier for us to keep track of all your choices in a single, well-organized location, enabling us to give you information after doing a more thorough analysis of your requests and relevant medical conditions.

Log Data

When you visit our website, we collect information from your browser. your IP address, browser type, browser version, the pages of our website you view, the time and date of your visit, the length of time you spend on those pages, and other data points might all be contained in this log data. To give you a better service experience, we use your IP address and/or country preference to determine your approximate location. The kind and configuration of the device you use to access the website or services will determine how much of this information we gather.

Why We May Use the Personal Data We Collect

- To personalize your experience: To tailor the content and experience you have on our website, to speed up your searches. We will utilize the domain of your email to infer your association specific to this trial.
- To make the site work as you expect.
- To ensure that content from the site is presented in the most effective manner for you and for your computer.

To Provide Services and Communications

How We Share Your Information

Law Enforcement Officials and as Required by Law:** When we determine that it is necessary to (a) comply with a law, regulation, legal process, or enforceable governmental request; (b) enforce or apply the terms of any of our policies or user agreements; or (c) protect the rights, property, or safety of us, our employees, our users, or others, we may release all or part of your information to third parties.

B. Third-Party Processors/Vendors: We may share with our third-party service providers who offer services like data analytics, marketing analytics, auditing, software development and maintenance, quality control and assurance, customer support, cloud storage, messaging and voice services, email delivery, and other services. These service providers are required by law to protect the privacy of personal information and put in place suitable security measures.

D. To Clients/Sponsors: We might disclose information to the sponsor-provided trial sites who have their permission to receive it.

Consent to Provide Your Information

When you attempt to sign up on the website for this trial, we request your consent to collect your PII and PHI. In doing so, we also make sure to clarify as to what you are signing up for with respect to that program or service as well as how we intend to utilize your personal information. We also provide you the choice to withdraw your consent at any time if you decide that you no longer wish to take part in the program or receive information from us (this is known as “opting out” or “unsubscribing”).

Retention of Personal Data

Depending on the purpose for which we process your personal data, we need to process one or more personal data. We will keep them for no longer than necessary to fulfil the purposes for which we collected it, including any legal requirements. Depending on each case, the processing will therefore be as follows.

We understand that the processing of these data is also beneficial to you to the extent that it enables us to assist you adequately and answer to the queries raised.	We will process your data for the time necessary to meet your request.
To send you communications or notifications	This processing is based on your consent.	We will process your data until you unsubscribe
To participate in the clinical study	This processing is based on your consent.	5 years

We will securely erase or anonymize your information when there is no longer a need for it, or if that is not possible, we will securely keep it until it can be removed. Personal Information that we delete will be taken off our live servers, databases, and website, but it might still be available in our archives if doing so is impractical or not practicable. We may store and utilize anonymous and aggregated information for performance reporting, benchmarking, and analytic purposes as well as for developing our services, to the extent that it is allowed by law and/or our contractual commitments.

Information Security

To ensure that your Information is not improperly lost, misused, accessed, disclosed, altered, or deleted, we take reasonable precautions and adhere to accepted industry standards.

We treat your Personal Data in a confidential manner and use at least the same level of care in safeguarding your personal data that it uses with its own confidential information of similar nature.

We will process your personal data in accordance with our internal policies and procedure, that set out security measures appropriate to protect your Personal Data.

International Data Transfer

It is possible for personal information to be handled and kept outside of Australia, Canada, or UK, whose data protection and privacy laws may not be equivalent to, or as protective as, those that exist in your country of residence. Any transfers of Personal Data outside your country will be done in compliance with the international data transfer restrictions.
